Mission of the LRP:

- Envision DYC facilities requirements and changes, 1-2, 5, 10 and 20 years from now
- Plan for potential future infrastructure changes to clubhouse, docks, utilities, etc.
- Set current and future infrastructure standards for repair and/or replacement projects
- Recommend/manage short term projects (1-2 years) that improve the esthetics, safety, and/or usefulness of the DYC clubhouse and docks (improvement vs repair)
- Help manage long range capital budget planning for major infrastructure changes/replacement.

2024 – 2025 Planning:

- Rebuild infrastructure and docking on West dock using new electrical infrastructure, install (4) 100-amp GFCI breakers to dock electrical legs
- Make the entry to the clubhouse and docks easier and safer through ramps
- Evaluate redesign to bubbler system
- Potentially set up cameras for Club member access online

2 to 5 Year Planning:

- · Set up Club for remote virtual meetings
- · Continue with electrical upgrades to other docks
- Remodel clubhouse bathrooms
- · Cosmetic and aesthetic upgrades to the Clubhouse
- Evaluate a section of floating dock
- 5 to 10 Year Planning:
 - Replace/remodel kitchen
 - Planning for more demand for electric as electric boats start affecting our club's needs
- 10 to 20 Year Planning:
 - Likely need dock surface and structure replacement project

DYC Short Term and Long-Range Planning and Infrastructure Committee Meeting Report (continued)

Ramp Project for 2024-2025

Entry Ramp: Entry from Park to Docks (\$5-6K)

- Convert the stair entry from the park to the DYC main dock/walkway to a ramp
- Construct a ramp using ADA specifications for ease of use and safety
- Easier access for people with wheelchairs, strollers, walkers, etc. and for equipment and supplies using carts or dollies

West Dock Ramp: Entry from Main Dock to Clubhouse Deck (\$5-6K)


- Convert the west staircase of the clubhouse front deck to ramps
- Construct a ramp up from the main dock to a platform at the clubhouse deck level
- Construct 2nd ramp from clubhouse deck level platform to west dock

West Dock Reconstruction with Electrical Upgrade (\$8K)

- Coupled with West Dock Ramp project to avoid duplication of effort
 Remove dock surface boards and all substructure wood and replace with treated wood
- Add in Pex water pipe (as needed) and conduit with electrical wiring based on our future electric requirements
- Add new electrical pedestals and outlets

Project Requirements:

- Dedicated teams to build the ramps for Entry Ramp, West Dock Ramp and West Dock Reconstruction
- The work will involve welding, steel cutting, lifting, holding and woodworking skills
- The framework will be made of steel and treated wood, topped with existing artificial wood decking
- Barge to lift the prefabricated panels into place on the existing dock walkway
- Workshop and welding and metal cutting tools for prefabrication
- Prefabricate substructure panels offsite at a workshop (TBD)
- Target either the Entry Ramp or the West Dock projects for 2024 and the other for 2025 based on resources, weather, and other constraints
- Requests will be sent out for members interested in becoming a part of any of these project teams
