There were several members in attendance with Jack Gaasch taking the opportunity to speak when the floor was open to members at the beginning of the meeting. Jack opened his remarks with a reminder that we are approaching the 78<sup>th</sup> anniversary of DYC and provided some history on a significant storm (Agnes) that occurred in the early 1970's, the damage that the club incurred and how the club proceeded with the storm restoration. He tied the history into how the club is now facing some decisions regarding maintenance of our facilities. He referred to a letter that was drafted and sent to the Board Members of DYC regarding the Vote #3 Capital Assessment for Pier and Understructure Replacement. Please see the letter in its entirety in the newsletter along with the list of all members who signed in their support of the letter.

In Board news, the club's membership in the Inter-Lake Yachtsman was renewed. Carl Waclawski presented the treasurer's report. In membership, it was noted that there are currently 99 members. There is a membership opening and the next person on the waiting list will be contacted and invited to the February meeting.

In education news, Donna reported that she has already been working with Jackie Patterson from JCC along with Hank & Julie Danielson to continue the partnership with JCC to offer sailing classes at the club this summer.

Vice commodore, Doug Reid expressed that he is looking / reaching out to any members that would be interested in serving on the Long Range Planning

In New Business, a reminder was noted that the membership roster update form included in your annual bill now has a line to designate a successor, please be sure to note on the form if you wish to designate someone. Concerns were discussed regarding pilings in need of repair and ideas on how to best proceed moving forward. Kathy Fox shared information she gained regarding how pilings are drilled for docks at the marina in Erie, PA. Robyn shared information on a pneumatic hammer capable of pounding in pilings that could be purchased and is operational off a boat / small barge. The Beardsly's and Danielson's toured the company in Naples, Florida where the hammer is made. Discussion ensued regarding concerns with NRG not being operational and the effect of possible ice damage and other long term considerations. This is a pertinent issue for the club and any input, ideas; suggestions should be conveyed to aid in finding the best course of action.

The board also discussed the capital assessment resolution that was voted on at the annual meeting. With points made in the letter received by the Board and reiterated by Jack Gaasch during member comments, questions were raised in regards to whether or not the vote went against the club's by-laws. Members of the Board had differing opinions regarding the issue and much discussion ensued. Bill Wright motioned to proceed with an assessment of \$400 to the members with Commodore Robyn Beardsley calling the motion out of order. Following discussion and consultation, Carl Hamann determined an appeal could be made in response to the out of order call. Paul Wallenhorst motioned to appeal and it was seconded and passed. In discussing the motion on the floor, Doug Reid motioned to table the assessment proposal for 1 month, which was then seconded and passed.

In the final order of business of the January meeting, Nancy Steffan motioned to make Joannie Will a senior member as the first person granted under the newly established succession arrangement. The motion was passed.

What seemed like an insurmountable task at the beginning of the day began to take shape, and by late afternoon, the job was done.

Ed commented on how hard Julie, my wife, worked. When it was done we were proud of our work. We had formed new friendships, discovered new things about ourselves and those who worked beside us.

Over the years there were many workdays. It was those workdays that gave us all a true sense of ownership, a sense of more than simply "belonging to", but of being a genuine part of the Dunkirk Yacht Club.

Lake Erie is the warmest and most biologically productive of the Great Lakes, and the Lake Erie walleye fishery is widely considered the best in the world.



### DYC\_letter\_capital\_assessment\_20151117

To: Members of the Board of Directors of the Dunkirk Yacht Club Regarding: Member Vote #3 Capital Assessment for Pier and Understructure Replacement

Date: November 17, 2015

At the recent DYC annual meeting on 11/7 a 'decision' was presented to the club, was voted on, and deemed passed by Commodore Paul Wallenhorst, who was chairing the meeting. This decision was "to authorize the club to create a Capital Reserve Fund" in an amount in excess of \$100,000 (see {1}, below).

Prior to the vote, Pat Bailey pointed out that the By-Laws of DYC limit the board "to establish(ing) a capital reserve fund with a maximum of \$10,000 per year and a maximum total of \$50,000." Bailey's statement was dismissed as not pertinent by Wallenhorst, who then proceeded to a vote. Subsequently, 60 members voted on the proposal with 37 in the affirmative.

In our opinion, Article IV, Section 8, of the Bylaws (see {2}, below) does not allow the Board to establish a capital reserve fund of more than \$10,000 per year and a total of \$50,000. In our opinion, this Section of the DYC By-laws does not allow the Capital Reserve Fund that was proposed. Support and explanation for this opinion follows: Firstly, Robert's Rules of Order are required to be applied at meetings of voting members of the DYC (see {3}, below.) However, Robert's Rules of Order are default rules and do not supersede requirements of the bylaws of the organization holding the meeting (see {4}, below.) Accordingly, the actions at the 11/7 meeting were first and foremost to be controlled by the DYC By-laws. Therefore, the offering of the 'decision' presented at the meeting was improper in that it was a request to allow an action that was not consistent with the DYC By-laws.

Secondly, the DYC By-laws do offer a method of changing its own By-laws in ARTICLE XI, AMENDMENTS, Section 1 (see {5}, below). This requires "a vote of two-thirds of the voting members of the Dunkirk Yacht Club present." While the vote on the Capital Reserve Fund did meet a majority test, it did not meet the two-thirds requirement for DYC By-law Amendments and should not have been deemed supported by the vote.

The procedural irregularities discussed above demonstrate (1) that DYC meetings must follow the DYC's By-laws, and the DYC By-laws cannot be superseded by Robert's Rules of Order because of the "contrary provisions" in DYC's stated rules of governance, and (2) that to pass the proposed Capital Reserve Fund would, according to our own DYC By-laws, require an Amendment and a two-thirds vote in the affirmative, which was not met.

Irrespective of the procedural irregularities highlighted above, some might try to argue that the decision was passed, and that the Board has requested and obtained permission to carry out the establishment of a Capital Reserve Fund as described in the Pier Funding Letter of 10.13.2015. However, the DYC By-laws expressly disallow such a fund. Notwithstanding the outcome of the vote, the DYC Board of Directors cannot choose this action and in fact is required not to establish the proposed Capital Reserve Fund which exceeds the limits in the DYC By-laws.

The solution to this problem is for the DYC Board of Directors to follow the By-laws and not create the described Fund. The Board should acknowledge the error, distance itself from the incorrect deeming of the decision as having passed, and move on.

We suggest that the Board seek to determine why more than a third of the voting members present did not support the 'decision' as presented. We believe that a workable, equitable, and acceptable method of carrying out required repairs at the DYC docks can be developed.
